- Determine your Executors - who administer your estate
- Provide full names, occupation, address, email and mobile phone numbers for all Executors and Guardians
- Choose backup Executors in case your first choice is not available
- Choose Guardians and backup Guardians for your Minor children
- What special Gifts of cash or personal possessions do you wish to bequeath
- Who will be your main beneficiaries e.g. Spouse/partner, children, grandchildren?
- Backup beneficiaries in case of disaster?
- Are there any immediate family members you wish to exclude?
- What age should minor children inherit?
- If you lose capacity before your death, who will you want to be your Enduring Attorneys and Guardians to manage your affairs?
- Make a list of your Assets and Debts
- Do you have a Family Trust or Company or Business that you own?
- Please provide details and copies of documents
- Are you planning to divorce or marry in the future?
- If you have an existing Will please provide a copy
